#### Extension of Last Date For Submission of Application Form

#### FOR FIRST YEAR OF POST HSC DIPLOMA COURSES IN PHARMACY FOR ACADEMIC YEAR 2022-23

It is Mandatory for all the institutes in the state conducting Diploma in Pharmacy course to obtain approval from Pharmacy Council of India, New Delhi (PCI) to run the course for every academic year. Approximately 125 existing institutes conducting Diploma in Pharmacy Course have yet not received PCI approval to continue the Diploma in Pharmacy course for the academic year 2022-23. In this regard PCI vide its circular No.14-56/2022-PCI/13107 dated 29/08/2022 informed that the approval process of existing institutes by PCI, for academic year 2022-23 is under process and some more time is required to complete the same.

This Notice is being issued for Extension of Last Date for Online Registration & uploading of documents, Documents Verification and Application Form Confirmation for admissions to First Year of Full Time **Diploma in Pharmacy** in the Government, Government Aided, University Managed and Unaided private educational institutes for the Academic Year 2022-23 in the State of Maharashtra.
