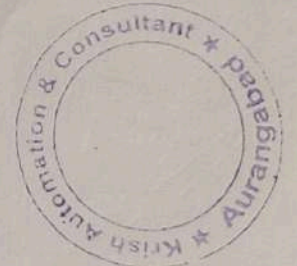
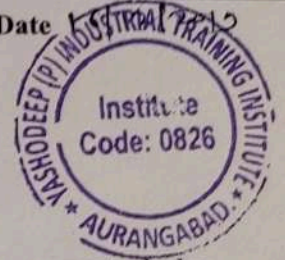
Faculty of R&D/Scientist/Engineer/Staff Exchanges:

ARTICLE 3: DURATION



ARTICLE 4: GENERAL MATTERS

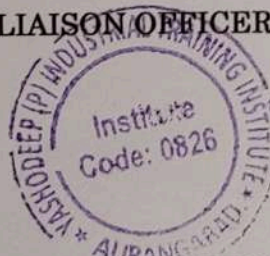
AMENDMENTS: The institution & the organization may amend this MOU only in a writing signed by each of their authorized signatories.






